





Tapestry Learning Partnership Publication Scheme on information available under the Freedom of Information Act 2000

The Board of Trustees (the Board) of Tapestry Learning Partnership (Tapestry) is responsible for the maintenance of this scheme.

- Information that is no longer readily available as it is contained in files that have been placed in archive storage or is difficult to access for similar reasons.
